President's Message

The 60th Annual VNA Convention, Coin & Currency Show is planned for September 21 - 23, 2018. For the last ten months volunteers and the VNA board have been striving to make the upcoming convention a success. Time is growing short. We are looking for individuals to help set up the hall, help dealers set up, and secure their inventory on Thursday, Sept 20th. We also need help to breakdown on Sunday, Sept 23, 2018.

We are looking for educational exhibits (both for prizes and for enlightenment), and for educational lectures. Scheduled are educational presentations on Biblical coins, colonial coins and large cents, with speaker schedules to be announced. We expect numerous exhibits and invite Young Numismatists to display exhibits. The VNA banquet on Saturday, Sept 22nd features guest speaker Larry Briggs, dealer, and part of the SEGS certification service. As in prior years the convention will be honored to welcome a group of homeschoolers on Friday, and the Boy Scouts for merit badges on Saturday, with youth coin auctions like last year. VNA member clubs are encouraged to rent vehicles for carpooling to the convention to increase attendance and allow members who may not be able to attend on their own to get to the show.

Unfortunately, the ANA seminar "The Fundamentals of U.S. Coin Grading" has been cancelled due to insufficient numbers of students. The VNA made major efforts to enroll enough students to continue the class, but we were unsuccessful. Hopefully we will succeed next year, if the program continues. At this time, the VNA has not heard from either the U.S. Mint or the BEP, so assume they will not be with us this year.

The VNA board may purchase surveillance equipment for the convention hall and for future activities, and we will have security from Thursday afternoon to Sunday afternoon, as in the past. We ask all attendees and dealers to always be aware of their surroundings and their neighbors, to help prevent theft, and ensure individual safety.

Elections for VNA Officers and Board members are due to be mailed out with show announcements along with information for the convention. I urge all members to vote and send in the ballots as soon as possible. Also, sign-ups for banquet tickets will be sent with ballots and announcements for the convention. All are welcome.

My hope is that we will again have a safe and successful convention, that many will attend, and communicate with others about coming to the show, both in 2018 and in the future. Thank you.

Wytheville Vouchers

After our most recent offering on local, municipal bonds of Virginia (*Funding the Virginia Home Front During the Civil War*, [The Virginia Numismatist](#), Fall 2017), some interesting, related numismatic material has come to light. The authors discovered nine “vouchers” from Wythe County, Virginia, which were issued to family members of soldiers away in military service. In their book, *Virginia Obsolete Paper Money*, Richard Jones and Keith Littlefield attribute these vouchers to the military, however, the *Order Book for Wythe County* reveals a civilian authority issued this “local benevolence.” On September 9, 1861, the justices of the Wytheville Court provided for support of local families who had family members serving in military units of Virginia or the Confederate States of America. Initially no amount of money was appropriated for this effort, but on December 8, 1862 the court appropriated the sum of \$15,000. The clerk of the court was authorized to issue bonds to raise the money for relief.

WYTHE COUNTY BONDS - When they appropriated the money, the court appointed eight district commissioners and gave them authority to set the amount of the bonds to raise the money. Unknown are the number of bonds actually issued, and in what denominations. Our research shows some jurisdictions specified detailed issuance requirements, but Wythe County did not. The bonds themselves could have been handwritten by the court clerk, as they only had to be in the proper form, signed and sealed by the clerk, but this was unlikely. Wytheville had a local press run by D. A. St. Clair, who printed banknotes for the South-Western Bank of Virginia, and private scrip issued by two local merchants; Hobson Clark and V. C. Huff. This leads the authors to believe that Wythe County bonds were printed, especially since the vouchers are pre-printed forms. Either way, no actual bonds have been located thus far.

WYTHE COUNTY VOUCHERS - Although not addressed in the court order, apparently it was left up to the commissioners to determine a family’s eligibility, and the amount to be distributed. The amount of each voucher was usually relatively small; \$4.00, \$5.00, \$6.00 and \$8.00. Exceptions included larger amounts of \$10.00, \$15.00, and an impressive voucher for exactly \$62.52. One voucher dated in 1864, distributed “one bunch of cotton” [attesting to exhausted finances late in the war.]

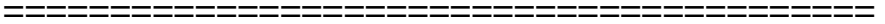

Perhaps the most interesting information contained in the vouchers is the family name of the soldier who received support from the county. As a case in point, a voucher given to Martha Austin on September 15, 1863 can be used to determine the name of her husband who, according to the voucher, was serving in the 51st Virginia Regiment. Given that there is a regimental history that lists all members of the 51st Virginia Regiment, we can see the service record of James Austin. His service record indicates that he enlisted in Company H, as a private, on 4/9/1862, was taken prisoner at Waynesboro,

sent to Harper’s Ferry, and then on to Ft. Delaware on 3/12/1865. He was released on 6/19/1865. He is described as having a sully complexion, dark hair, blue eyes and was 5’ 9” tall. He died sometime before 1912.

This discovery from Wythe County, Virginia adds another jurisdiction to those already identified by the authors as local Virginia municipalities that issued bonds for the home front during the Civil War. Adding Wythe County, we now have a total of twenty-nine. The authors are pleased to report that after our initial article was published in *The Virginia Numismatist* (Fall 2017), we were contacted by two collectors who each added a new municipality to our growing list. These two collectors have our thanks. We continue to encourage other local bond collectors and Virginia historians to contact us with any further information they may have, that will increase our pooled knowledge. Coins go to War

PART 2 – (Civil War Through WW I) by Michael T. Shutterly

The Civil War

It is often said that “Truth is the first casualty of war,” but specie coinage is the next casualty after Truth. The uncertainties of conflict lead people to hoard hard money – coins – as they await their desired outcome during unsettled times. Exigencies of the Civil War (April 12, 1861 –May 9, 1865) prevented Confederate coinage from entering commerce; instead the Confederacy issued a flood of promissory banknotes, payable after victory, but that was only because the Confederacy had a small and diminishing treasury of foreign, and older issue U.S. coins, that had to be paid out overseas for military goods. The Confederacy never developed a meaningful “national” precious metal coinage system. In both the Union and the Confederacy, gold and silver U.S. coins largely disappeared from circulation at the start of the War; by 1862, even the one cent coin was hard to find though the Philadelphia Mint was pouring out cents in the tens of millions. The cent was then made of a copper-nickel alloy, and the rising

cost of nickel added to the problem. Merchants in the North responded to the coin shortage by issuing what we know today as “Civil War Tokens,” which were usually made of bronze (an alloy of copper and tin). This substitute for legal money did not sit well with the U.S. Government, which responded in 1864 by changing the metal alloy of the cent from copper-nickel to bronze, and then began enforcing the prohibition to the issuance of private Civil War Tokens. The Mint introduced an entirely new coin denomination, the two-cent piece that same year, made of the same bronze alloy as the new cent, and it weighed exactly twice as much as a cent.

The two-cent piece was the first U.S. coin to include the motto “In God We Trust.” The motto reflected the strong religious feeling that should the Union dissolve, and antiquarians look back on the short-lived “Liberty” series of coins from the former United States, it would be obvious why they were no more. Coins of foreign lands typically do reference the Deity in some manner, “By the Grace of God” they rule. The Civil War was not going well for the Union in 1863 and inspired such soul searching. In March 1865, just a few minutes before taking the Oath of Office at his second Inauguration, President Lincoln signed a bill calling for a nickel three-cent piece, intended to help relieve the coin shortage precipitated by the Civil War, but that was not the most important reason for the coin: the real reason was that James Wharton, who controlled nickel mining in the United States, needed a market for his product, and James Wharton was very well-connected politically at the time. Wharton’s influence extended beyond providing the metal for the three-cent piece, and the five-cent “nickel” coin that emerged in 1866, and which continues to be struck today. He was one of the founders of Bethlehem Steel, and he endowed the Wharton School of the University of Pennsylvania, to become the first collegiate school of business in the world. The resumption of specie payments for obligations of the United States took about five years after the

war for enough coin to flow back into U.S. coffers from overseas holdings to be able to redeem paper notes for pay outs in gold and silver coin.

Spanish American War

U.S. coinage remained unaffected during the Spanish-American War (April 21, 1898 – August 13, 1898), which did not last long enough to have any impact at the time. After the declaration of war on Spain, the Philippines came under U.S. sovereignty in 1899, and the Philadelphia and San Francisco Mints began striking coins for the Philippines in 1903, using American standards. The U.S. mint at Manilla was established in 1920.

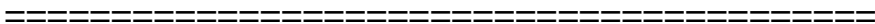
World War I

World War I (July 28, 1914 –November 11, 1918) influenced the designs of some U.S. coins, but did not affect the metal alloy of any coin, nor did it impact the money supply. Two years after Great War erupted in Europe, but four months before the United States abandoned neutrality in 1916 and joined the fray, Hermon MacNeil's Standing Liberty design replaced Charles Barber's Liberty Head design on the quarter dollar. The new coins showed Liberty holding an olive branch in her right hand, symbolizing a wish for peace, but her left arm uncovers a shield, showing the determination of the United States to defend itself if called to War. The olive branch in the right hand and shield in the left is significant in heraldry: the right side (dexter) is the more important, the left (sinister) subordinate, so the image shows the nation's preference for peace. Although the first of the new coins appeared after the Presidential election of 1916, the design was developed and approved during that year's political campaign, when Woodrow Wilson ran on the platform "He Kept Us Out of War."

After the United States declared war on Germany and Austria-Hungary in 1917, the design of the quarter dollar changed: on the reverse, stars were rearranged, and the eagle flew a bit higher in the field, while the obverse now showed Liberty with a coat of mail covering her previously-exposed right breast. Some writers have argued that the design change was due to American prudishness about Liberty's exposed breast, but there is no contemporary evidence for this claim, first made 30 years after the coins appeared. MacNeil, the designer, requested the changes, and it seems that this was simply his preference. As a practical matter, of course, with the country now fully engaged in War, Liberty had to protect her assets.
