VNA Convention Banquet Speaker will be Walt Ostromecki – Former ANA President

Making the Numismatic Hobby a More Fun-Filled Lifetime Adventure for All is the topic Walt Ostromecki will address at the VNA banquet. Walt has been a member of the American Numismatic Association (ANA) over 40 years, serves as an elected official of the ANA Board since 2005, the most recent two years as President. He was a national volunteer for coin conventions, served as education committee chair, summer seminar instructor, and national coordinator of the club representative program. He attended his first ANA convention as a volunteer worker in 1975. Walt attained BSA Eagle Scout serving as youth leader, and merit badge counselor for coin collecting within his home state of California. His key hobby outreach provided fun and educational services to numismatic groups in nine western states since the mid 1990's – including BSA and GSA merit badge workshops. Walt Ostromecki has received numerous top ANA and other regional awards.

VNA Sponsors *Virginia Tokens* - Expanded 2nd Edition By David Schenkman and Eric Schena

In 1980, David Schenkman's Virginia Tokens was the first work to document the trade tokens from the Commonwealth and helped set the standard for state token catalogs nationwide. Now, thirty-five years later, the second revised edition is ready. Tokens in Virginia have a long and distinguished history and offer the exonumist a wide spectrum of specialties. From Hard Times store cards, transportation tokens dating back to the 1860s, coal scrip, to trade tokens and picker's checks, Virginia Tokens seeks to document the many varied aspects of exonumia throughout the state in a convenient and easy to use format. With nearly 6,000 different tokens listed from roughly 2,250 different merchants located in approximately 770 towns, the new 2015 revision more than doubles the number of known listings from the original catalog. The revised second edition includes an expanded introduction that features a history of tokens in Virginia, as well as details on several of the principal token manufacturers. In addition, tips on collecting will benefit both long-time specialists as well as novices to the field. The catalog also features hundreds of full color illustrations throughout. Not only tokens are pictured, but also related images add to the historical interest and flavor of the pieces. Rounding out the book is a comprehensive index of merchants that will help collectors to quickly identify mavericks.

In addition to *Virginia Tokens*, David E. Schenkman has authored seven other token catalogs including *Merchant Tokens of Washington*, *D.C.*, *Maryland Merchant Tokens*, and recently in 2009 *West Virginia Merchant Tokens*, all of which have become standard works. Schenkman has been a prolific writer throughout his numismatic career, serving as editor of the Token and Medal Society's *TAMS Journal* from 1982 to 2010, a task that included editing all the books published by that organization during that time. The second edition of *Virginia Tokens* continues in this fine tradition of ground-breaking research and will no doubt become an influential work on merchant tokens for years to come.





Expensive But Undervalued \$3 Gold By Mark Benvenuto

It's a fair bet to say that except for those of us with deep pockets, collecting \$3 gold pieces by date and mint mark is something of a fantasy, a wish-list item, if you will. The coins just seem too expensive for anyone to really look at amassing the series. Let's look in a bit of detail though, and see if there might be some way for us to buy in, some way to at least own a few of these strange, uncommon gold pieces. When it comes to gold coinage, the \$3 denomination was not one of the originals authorized in the 1790's. it was by the Act of February 21, 1853, when Congress authorized this small gold piece [at 0.145 Troy ounces of pure gold], and 1854 before the Mint could bring any of them to the public. The "Princess" design of Lady Liberty wearing a Native American headdress, was the artistry of Mr. James Longacre – one of many of his works that grace United States coins. that first year saw 138,618 pieces produced at the Philadelphia Mint, 24,000 coined at the branch facility down in New Orleans, and just 1,120 made at the branch Mint in Dahlonega, Georgia.



These first year of issue \$3 gold pieces give us mintage highs and lows within the series and are distinguished that first year by the word "Dollars" in small letters on the reverse of interest to collectors by type. That first year the folks at the Philadelphia Mint probably didn't know it, but this would be the biggest single mintage for the entire series even though they would be produced all the way up to 1889. Actually, the 1854 issue of Philadelphia is the only one ever to make it to six figures. The next closest is

the 1878 with 82,304 minted as its official tally, making 1854 the most common date in the series. Today it will cost about \$1,200 to land one in a grade such as EF [Coin World, July 2015 Retail Price].

Southern Appalachian gold production had peaked long before Dahlonega produced its 1,120 \$3 gold pieces – even the California Gold Rush of 1849 was a couple of years in the past. But this issue can still serve as something of a benchmark for a rare \$3 gold piece, since aficionados of early gold are always attracted to the scarce 'D' and the 'C' mint marks. The same EF grade 1854 Dahlonega will now cost about \$19,500 [Coin World, July 2015 Retail Price]. By any stretch, that's a lot of green for a single coin. But here's where we find our first interesting twist of numbers and prices: the 1854-D is more than 100 times less common than the 1854, yet it costs only about twenty times more. That doesn't make it cheap, or some kind of sleeper, but it does give us pause to think. Are there other low mintage dates/mint marks within this series that might be worth looking at in terms of cost?

In the entire \$3 gold piece series, from 1854 all the way to 1889, there are only nine date / mint mark combinations with over ten thousand coins struck. That first year of 1854 is the lone year with more than 100,000 coins extant. The following five years comprise a sort of second tier of "somewhat common" ones. The 1854-O, the 1855, the 1856, the 1856-S, the 1857, the 1857-S (the smallest in the club, with only 14,000 pieces), the 1859, and two more, the 1874 with 41,800 (revived after the suspension of specie during the Civil War), and the 1878 with the already-mentioned 82,304 pieces are the coins most likely to be encountered. Putting not only these dates together, but also their prices, a person finds that the baseline figure is about \$1,500 for somewhat common coins in the EF-40 grade, with a couple being higher. The 1854-O and the 1857-S are the only real hiccups in this grouping, with each costing about \$2,750 in that EF grade.

Admittedly in looking for a pattern to prices, and in looking to determine if these gold pieces can be "collected," we are making assumptions. The biggest on survival rate is that all the pieces listed in the official tally survive today. Given up to eighty years of gold coin circulation since 1854, and valued only at face value, worn and damaged, soft gold pieces would have been withdrawn from circulation by banks, melted, and made into new gold coinage until 1933; others were used to make jewelry, exported or lost, leaving only a fraction to survive. But still, we have seen that the single most common coin in this series costs about 2/3rds of those in the second

tier. And, importantly, the second tier is expensive, but not insanely so. A person could save up for one of these.



The obvious next place to look among the \$3 gold pieces is at the dates and mint marks that ring in between one thousand and ten thousand coins. There are plenty of them in this zone, and no matter what sort of prices we may uncover, it will probably be hard to find them, even at the biggest They are after all, scarce at best, rare at worst and beware of counterfeits. With that in mind, a look through the major price guides indicates that several of these rarer \$3 gold pieces cost about \$1,500 -\$1,750 in the EF grade we've been using for our comparisons. The last two years, the 1888 and the 1889, which have totals of 5,000 and 2,300 coins respectively, certainly fall into this price range, having been absorbed by collectors and having a high survival rate. So do all the years from 1867 to 1870 which gives a sense of how few collectors demand these coins by date, rather than seeking a single example to complete their gold type set. We may indeed have uncovered some sleepers here, coins that are quite rare based on their low official mintages, but seriously undervalued. We started by commenting that the \$3 gold pieces were perceived by many to be too expensive to collect as a series - and if you hold fast to something like a \$100 upper limit to your numismatic purchases, these coins are always going to be out of reach. But note how widely different the mintages in this series are, and yet how close the price tags can be, at least for coins that have circulated a bit. We may not be tempted to stop collecting other series in favor of these gold pieces. But it does appear that adding one or two to any collection might not be as hard as we generally think, food for thought.

- All ADULT exhibits are to be in place by 10 AM on Friday, 25 September 2015 and are not to be removed before noon on Sunday, 27 September unless approved by the Exhibit or Bourse Chairman. YOUTH exhibits may be set up prior to 11 AM Saturday and taken down after 3 PM Saturday, although longer display times are encouraged, if possible.
- All VNA provided case keys are to be retained by the Exhibit Chairman.
 It is understood that your exhibit case (s) will be opened <u>ONLY</u> in your presence.
- All materials in a display must be the exclusive property of the exhibitor. Any material in a display which is not genuine must be so identified.


